We, the I-SPIE Conference Planning Committee, are reaching out to your council seeking financial support for the forthcoming I-SPIE Conference 2020. The conference will take place at CSU, San Francisco on July 16th and 17th of next year. This annual conference has been key to our consortium's success and has allowed us to learn about new interlibrary loan (ILL) technologies, build stronger bonds between campuses, and provide a better level of service to the entire CSU community. Your support of this conference is an investment in advancing learning and knowledge creation for every student, faculty, and staff member in the CSU system.

As technology changes, so do the resources and practices of ILL work. This conference is vital because it affords us the opportunity to keep up to date on these current trends, while deciding how they might benefit us as a resource sharing community. A copyright and information policy advisor, Courtney has started a "Copyright First Responders" initiative which educates library workers on commonly misunderstood copyright issues and promotes community engagement with copyright. In past ILL conference presentations, he has discussed how ILL is going to enhance the open access movement and CONTU's continued relevance to our profession. Another organization we are interested in having is Project ReShare. Project ReShare has given presentations at various ILL conferences over the past few years. The ReShare Community is a group of libraries, consortia, information organizations, and developers with a bold vision for building a user-centered, app-based, community-owned resource sharing platform for libraries to set the standard for how we connect library patrons to the resources and information they require. Their perspective can help us find new opportunities for CSU patrons and think about our profession in a new way.

Overall, the 2020 conference is going to cover a wide range of topics (data analytics, evidencebased decision making, system enhancements, copyright, emerging ILL technologies, equitable access, etc.) with presentations given by both CSU I-SPIE members and outside experts. As always, our premier goal is to enrich our communities and ignite the spirit of collaboration. Any support you can offer us, financial or otherwise, toward making this conference the best it can be would be greatly appreciated.
